GAIL (INDIA) LIMITED has informed the Exchange that Board of Directors at its meeting held on February 10, 2020, has declared Interim Dividend of Rs 6.40 per equity share. The record date for the purpose of payment of dividend is February 18, 2020.

Adjustments for Futures Contracts:

Base price of the Futures contracts on February 17, 2020 will be reference rate less aggregate amount of dividend i.e. Rs. 6.40/-. The reference rate to be reckoned for this purpose shall be the daily mark to market settlement price of the relevant futures contract.

Adjustments for Options Contracts:

The full value of dividend i.e. Rs. 6.40/- would be deducted from all the cum-dividend strike prices on the ex-dividend date. The details of the old and corresponding new options contracts that shall be available for trading from February 17, 2020 would be notified on February 14, 2020.

Members are advised to load the updated contract.gz file in the trading application before trading on February 17, 2020. This file can be obtained from the directory faoftp/faocommon on the Extranet server.
