The brief particulars of the Scheme of Arrangement are as mentioned below:

The National Company Law Tribunal (NCLT), New Delhi Bench vide its order dated May 01, 2019 has approved the Scheme of Arrangement between DCM Limited (Demerged Company) and DCM Nouvelle Limited (Resulting Company) and their respective shareholders and creditors.

The scheme of arrangement, inter alia, provides for demerging the cotton textile business undertaking of DCM Limited to DCM Nouvelle Limited, a wholly owned subsidiary of DCM Limited, as a going concern.

In consideration of the demerger and transfer of the Demerged undertaking, the Resulting Company has allotted equity shares to shareholders of the Demerged Company in the following manner:

“1 (one) Equity Share of INR 10/- each of the Resulting Company, credited as fully paid up, for every 1 (one) Equity Share of INR 10/- each, fully paid-up held in the Demerged Company (“Entitlement Ratio”).
