### Transaction Fees on Far Month contracts

---

In terms of provisions of the Rules, Bye-Laws and Business Rules of the Exchange and in continuation to Exchange Circular no. MCX/TRD/691/2019 dated December 6, 2019; the Members of the Exchange are notified as under:

The Exchange has decided to extend levy of flat concessional transaction fee of Rs. 1.30 per Rs. 1 lakh of turnover in far-month contracts\* of Group A commodities for a period of another 6 months up to December 31, 2020 and will be reviewed thereafter.

*\* Far-month contracts shall be contracts other than near and next month contracts (i.e. third and subsequent expiry contracts). However, when near-month enters tender period, fourth and subsequent expiry contracts are only considered as far-month contracts.*

The revised list of commodities under Group A and Group B along with the corresponding slabs of turnover and transaction fee rates is attached as **Annexure**.

Members are requested to take note of the above.
